

Indian equity markets remained under pressure as sustained foreign investor selling and elevated crude oil prices driven by geopolitical tensions weighed on sentiment. Investors stayed cautious ahead of the U.S. Supreme Court's ruling expected on Jan 14 2026, on the legality of tariffs imposed by the U.S. administration on major trading partners. These tariffs, introduced in Apr 2025




## Nifty 50 Earnings Yield Vs 10 Year Gsec Yield




