





Indian equity markets surged after the RBI unexpectedly cut the repo rate by 50 basis points to 5.5%, reduced the CRR by 100 basis points to 3%, and lowered its inflation forecast by 30 basis points to 3.7%. These moves signal a strong push to boost liquidity, investment, and consumption, underscoring the RBI's commitment to supporting economic growth.

NTPC announced that its group installed generation capacity has reached 80,265 MW, following the commencement of 110.25 MW commercial supply by its subsidiary, NTPC Renewable Energy, from the 1,255 MW Khavda solar project.

Oyo, the IPO-bound global travel tech platform, announced its plans to accelerate the expansion of company-serviced hotels in FY26. The company aims to double the share of booking revenue from these properties from 22% to 44%, while also expanding its footprint from 124 cities to over 300 cities across India.

Engineering firm RITES Ltd announced that it has signed an agreement with Hindustan Copper Limited (HCL) to jointly develop the supply chain for metals and minerals including critical minerals both in the domestic and international markets.






Fungibility

Definition: Fungibility refers to the quality of being able to substitute or interchange one unit of a financial instrument for another unit of the same financial instrument. However, in trading, a financial instrument is said to be fungible if buy or sell of the same financial instrument can happen on a different market with the same end result.



Explanation

There are many financial instruments which qualify to be considered as fungible. Some of those financial instruments include individual stock, gold, silver, currencies etc. These fungible financial instruments are generally used in arbitrage trades as price difference often arises due to difference in location.
