


Indian equity markets gave up early gains to conclude significantly in the negative due to persistent challenges in the Middle East and ongoing FII outflows. Furthermore, market sentiment was affected by escalating tensions in the Middle East due to the Israel-Iran conflict, leading to a decrease in oil stocks in India.

Kalyan Jewellers announced a 37% YoY rise in consolidated revenue for the Q2 of FY25, attributed to a 39% increase in revenue from India and a 24% increase from the Middle East. The company inaugurated 26 new showrooms, raising the total number to 303, and experienced a 30% growth in its digital platform.

Steel Authority of India Limited (SAIL) and BHP have signed a Memorandum of Understanding (MoU) to investigate ways to reduce carbon emissions at SAIL's steel plants. Their goal is to evaluate different reducing agents such as hydrogen and biochar, develop local research and development skills, and tackle greenhouse gas emissions in the steel sector.

Adani group has started blending green hydrogen with natural gas used for cooking in some areas of Ahmedabad. This effort aims to reduce emissions and achieve net-zero goals. Adani Total Gas Ltd, the group's partnership with French company TotalEnergies, is now adding 2.2%-2.3% of green hydrogen to the natural gas supplied in Shantigram, Ahmedabad.





## Securities Transaction Tax

Definition: Securities Transaction Tax (STT) refers to the tax levied on transaction (purchase or sale) of securities listed on the Indian stock exchange. Such securities include equity shares, derivatives and equity-oriented mutual fund units. The rate is specified by the Central Government from time to time.



### Explanation

STT is levied at the rate of 0.100% on purchase or sale of equity shares in a company, where such contract is settled by the actual delivery or transfer of such share or unit. However, for sale of a unit of an equity-oriented fund, where such contract is settled by the actual delivery or transfer of such share or unit, the rate has been revised to 0.001% with effect from June 1, 2013. The same shall be borne by the seller. Meanwhile, the rate of STT is 0.025% for sale of equity shares or a unit of equity-oriented fund, where such contract is settled other than by the actual delivery or transfer of such share or unit.
