






Smart Beta Index

Indian equity markets snapped its five-day losing streak and closed with healthy gains amid positive global cues. The key benchmark indices rallied and reached fresh high supported by all-round buying across the sectors as investors went for value buying following the recent fall. Sentiments were boosted following the faster-than-expected U.S. GDP growth data.

Shriram Finance announced a consolidated net profit of Rs. 2,022.8 crore (attributable to owners of the company) for Q1FY25. The company's profit increased by 19% compared to the Rs. 1,705 crore reported in the same period last year. However, net profit after tax for the period from total operations stood at Rs. 2,031 crore.

Cipla announced a 17.4% increase in net profit to Rs. 1,178 crore in Q1FY2025. This growth was primarily driven by robust sales performance in the U.S., India, and South Africa. The company reported Rs. 1,003 crore net profit during the corresponding period of the previous year. Revenue from operations rose 7% YoY to Rs. 6,694 crore in Q1FY25 compared to Rs. 6,258 crore in Q1FY24.

crore profit d last od at DLF Ltd announced a 23% increase in its consolidated net profit to Rs 646 crore for Q1FY25. This marks a significant rise from Rs. 527 crore in the corresponding quarter of the previous year. Revenue from operations in the reporting quarter fell 4% YoY to Rs. 1,362 crore against Rs. 1423 crore in the same quarter of the previous year.


